School Fees and Mode of Payment

Fee Rules:–

1. 'No dues certificate' before the Annual Examination is to be obtained from the Accounts Department.
2. Fees can be paid either in Cash or Online Mode Only.
3. Bus fee is subject to change in future as it is dependent on many factors such as cost of fuel, taxes, insurance, permit, etc. The decision taken by the school management is final and binding in this regard.
4. If two children of one parent take admission, then 15% of tuition fees will be waived off for the student of lowest class.
5. If three children of one parent take admission, then 25% of tuition fees will be waived off for the student of lowest class.
6. A discount of 10% on "Tuition Fee" will be given if entire fee is paid (lump sum payment). No rebate or discount will be given on other fees and bus fees.
7. For Staff children 25% concession in tuition fees will be given.
8. Only one type of concession at a particular time will be given to parent. The decision of the same is reserved with School. Multiple type of concession will not be given.
9. A fine of Rs. 500/- will be charged if the cheque is returned / dis-honored by the bank due to any reason.

Fee Rules: –

1. Bus Fee is not refundable under any circumstances.
2. Bus Fee is payable in two equal installments.
 - a. Start of the Academic Session / At the time of opting bus facility: Between 1 to 10 April 2024: 50%
 - b. Between 20 to 30 October 2024: Balance 50%
3. Route cannot be changed once opted.
4. As far as possible nearest bus stop shall be allotted to the student. It will not be possible to provide bus stop other than the main road lanes as bus cannot enter the lanes.
5. Once the Transport facility is opted the entire fees has to be paid. It is not possible to discontinue the transport facility during the session.
6. Transport charges are likely to be changed in case of abnormal increase as the charges depend on various factors such as rates of fuel, government guidelines, COVID protocols, seating capacity, etc. In this regard, Management decision shall be final and binding.
